Index Objective

The S-Network Composite ETF 1000 Index measures the float market cap performance of the largest 1000 US Exchange Traded Products.

Highlights

Top 1000 listings on public US stock exchanges excluding OTC listings.

Dates

Snapshot Dates: The last trading day of the second month of each calendar quarter.

Reconstitution Date: Indexes are reconstituted quarterly on the third Friday of the last month of each calendar quarter.

Weight Date: Thursday prior to 2nd Friday of Rebalance Month.

Rebalance Dates: Indexes are rebalanced quarterly on the third Friday of the last month of each calendar quarter.

Index Construction

Universe

All publicly listed US ETPS excluding OTC listings.

Selection

The top 1000 universe constituents by market cap that meet the following criteria at the Snapshot Date preceding the Reconstitution Date:

- 1- R-Score¹ > 1 (10% buffer for current constituents)
- 2- Traded at least 22 days in the past 3 months.

Weighting

Market Cap

Rebalancing and Reconstitution

Rebalances: Rebalances are on the Rebalance Dates.

Reconstitutions: Reconstitutions are on the Reconstitution Dates using data as of the Snapshot Dates.

Share weights use data as of Weight Date.
